### INVITATION FOR APPLICATIONS FOR VACANT POSITIONS IN THE BOARD OF DIRECTORS OF GATAMATHI WATER AND SANITATION LTD

Gatamathi Water and Sanitation LTD is a public water utility company fully owned by the County Government of Murang'a with a mandate to provide water and sanitation services in Mathioya Sub-County, Rwathia in Kangema Sub-County and parts of Gaturi in Kiharu Sub-County.

The company seeks to fill the vacant positions for the Board of Directors. The Board of directors comprises of representatives of stakeholders identified by the Company and the County Government of Murang'a in accordance with the Water Sector Corporate Governance Guidelines issued by the Water Services Regulatory Board.

The Board has vacancies for representatives of the following stakeholders:

- ii. One [1] director representing Special groups – Youth, People living with disability and Water Resource User's Associations,

### ELIGIBILITY

- Tax Compliance Certificate from KRA
- Clearance Certificate from Ethics and Anticorruption Commission [EACC]

[ii] Persons in the current professional and social relationships with directors of the company cannot become directors of the company
